# GREEN **OBJECTIVES**

Green Monday's founder emphasises the urgency for us to change our behaviour, writes **Jefferson Mendoza** 

#### **GAME-CHANGERS**

ong Kong's social enterprise Green Monday raises awareness about the benefits of a greener diet as the launch pad for promoting an "earth-friend-

According to David Yeung, Green Monday's founder and CEO, the need for food has been one of the biggest dangers to the environment and one of the largest contributors to climate change from emissions of greenhouse gases, energy used for food production and water usage for food processing.

"We want to tell people what's wrong with the food system," says Yeung. "And to emphasise the urgency for us to change our behaviour altogether."

Green Monday encourages individuals not to eat meat one day a week, such as on a Monday. This will improve their health because the meat they eat might contain antibiotics used to feed animals. This small shift in diet also helps to reduce the individual's own carbon emissions.

Yeung's views on food changed in 2001 when he became a vegetarian. His father had been a vegetarian for about five years prior to that, but didn't actively persuade his son to become one. The decision was entirely Yeung's and came when he asked himself "why hurt life just for our personal so-called 'enjoyment'?"

A decade later, he launched Green Monday in Hong Kong after meeting a friend and discussing the topic of food. "In 2012, I had this blueprint with multiple entities under the Green Monday plat-

form. That can ultimately enable shift in people's diets," says Yeung. The response was immediate and the movement has been a huge success. Over

400,000 local students, and 1,000 restaurants have already joined Green Monday's pro-But Yeung says that he would be lying if he had envisioned what Green Monday has

In 2015, Green Monday created Green Common, a plant-based concept store, which offers retail items, a place to learn to cook the latest recipes, and a dining area.

Since its launch and even to this day, Yeung has had to demystify vegetarian food which has traditionally been perceived as not so nutritious nor a good source of protein since there is no meat involved.

"Since day one, we have avoided using words such as 'meatless' or 'meat-free.' That blatantly means you are depriving people of something," he says. According to Yeung, another obstacle has been the way vegetarian food has often

been presented to meat-eaters that are not appetising enough. Yeung says people tend to lean towards food that is convenient for them, even if their

intake has detrimental wider implications in the long run. "That's why I always say green must come with innovation," Yeung says. "There

must be a twist. There must be something that people find that is novel, that is exciting. And that's value-added." To counter the mundane approach to plant-based dishes, Green Monday innovates

on an almost daily basis. And every month, they launch new menu items, drumming up excitement among consumers. For example, the company launched the "right treat" choice in April, unveiling its first all-purpose plant-based pork, which it has called "The Omnipork".

When asked about the response from the meat industry of his views, Yeung says there have been no confrontations, which he puts down to Hong Kong's location and the lack of a powerful farm lobby.

Green Monday has also deliberately cultivated the message that it's still okay for people to eat meat. "We know that it will take time to transition. I always openly share with people the fact that my own wife still eats chicken and fish," Yeung says.

Today, Green Monday has six Green Common stores in Hong Kong. And it aims to expand further beyond the city's borders.

"That is not the next step, but the overall direction. But if you look at the more immediate standpoint, it's to grow in Hong Kong," he says.

Still, Yeung remains passionate about what he believes in. He recalls that in the early years he gave talks that only a handful of people attended, but it didn't dampen his en-

"Do something you are passionate about. Authenticity, passion and perseverance, those are key elements to have a chance of success. I won't say they will guarantee success, but it gives you a chance to succeed in what is a competitive world out there," Yeung says.

# How can I get my career back on track?

feel so lost. When I was younger, I focused all my efforts on my studies. My sole aim was to get into a good university, because my school and family told me that was the key to a good job and a good life. And so I dedicated myself to that singular dream, having faith that, as long as I did my part, I'd be happy in the end.

Suffice to say it didn't quite work out as planned. I got into a good university and did well enough, and I managed to get a decent job when I graduated. But somewhere along the way I lost my drive, and I'm not entirely sure I know what I'm doing with my

I almost feel like I'm just going



wrong, I'm good at my job and do make an effort. But I don't find it fulfilling, and I'm not one of those people who gets up in the morning raring to go to work. If anything, I'm starting to become more indifferent, and am afraid of what I'll become if I don't snap out of it. How can I find my way again? Jack

Oh dear...all work and no play has really done a number on you. And by no play I mean you never let yourself freely dream and imagine. You've never played with the endless possibilities of what you could do and could be.

Sure, you had dreams. But can you honestly say they were completely your own? Your entire upbringing was sold on the idea that your life is the natural result of the job you get from attending the university where your high school grades earned you a right place.

The problem is a fixation on the destination without giving much thought or awareness to living and enjoying the journey. This isn't self-actualisation, it's self-entrapment. You assumed that following the path laid out for you would make you happy. But, along the way, you never developed your own individual

dreams. Clearly your current track doesn't inspire you. So what does happiness mean for you? What are your passions? What kind of work would you find fulfilling? How could you see yourself applying your skills to your dream job?

First, define your core values and what you believe in. This will give you some insight into the kinds of careers that would fulfil you. Next, reflect on what you're good at and enjoy doing. Think about the type of work you'd be happy to do every day.

Then put it all together and imagine the different routes you could take to live that vision. Identify the key ideas, principles and themes that underpin the possible career paths open to your skills and attributes. These are an indication of your sense of purpose, which is a powerful catalyst for change.

With a clearer vision and purpose, think about how to narrow the gap between your current and desired work. It may be a quick transition or require longer-term planning. Even if you want to leave your current career, find ways to overcome the divide rather than burning your bridges. You should also set a series of short-and long-term goals.

Each goal is a milestone in your newly defined aspirational career journey, and an opportunity for constant ongoing evaluation. Make the goals achievable, and string them together to create momentum.





# ACCOUNTING FORUM HIGHLIGHTS CAREER OPTIONS

Young CPAs need to adopt new ways of thinking and add value wherever possible, writes Wilson Lau

ith the arrival of the "Accounting Plus" era, young CPAs need to adopt new ways of thinking if they are to meet changing workplace demands and capitalise on the exciting career prospects offered by ever more diverse roles.

That was one of the core messages from October's "HKICPA Career Forum 2018", which was held at the Science Park and emphasised the importance of professional accountants' role as a vital "connector" within the business world, as well as the need for them to add value wherever possible.

Organised by Hong Kong Institute of Certified Public Accountants, the event attracted hundreds of undergraduates keen to hear the views and insights of thoughts leaders and eminent figures within the profession.

For instance, HKICPA president Eric Tong noted that "Accounting Plus" principle had helped many CPAs advance to leadership positions in their respective organisations, but also that those career journeys usually began with experience in auditing.

"Young CPAs who work in auditing are exposed to the operations of various companies and sectors and accumulate vital insights," Tong said. "The profession is also the 'Critical Piece' because CPAs working for businesses have become increasingly forward-looking. They are able to leverage their insights to give forecasts and advice. And with their combination of higher-order capabilities, many HKICPA members are not just CFOs, but have diversified into other value-adding specialisations."

Reflecting the concept of "new thinking" which underpinned the forum, Tong explained that use of a "focus group" format created a more informal setting. This, in turn, allowed attending students to move around more freely, thus encouraging more interaction between speakers and audience members plus a greater exchange of ideas and viewpoints.

Jonathan Ng, HKICPA's acting registrar, added that the profession continued to offer a diverse range of rewarding career paths for young people. These might be seen as something like "accounting plus information technology" or

"accounting plus risk management".

Also, thanks to China's Greater
Bay Area scheme and the Belt and
Road initiative, Hong Kong's status as
a regional finance hub looked secure.
This meant that the profession had
further appeal, with companies in
every sector having a need for CPAs'
expertise.

Importantly, it was also confirmed that the New Qualification
Programme will be launched in 2020.
It will help to broaden access to a CPA qualification, opening another door for interested students, including those without a degree in accounting.

Ng said the forum was a great chance for students to explore everything the profession offers and reflect on where it could take them.

Indeed, many students made a point of visiting the Focus Group zone to hear how successful CPAs had built their careers and moved into different roles and industries. For example, at the "Audit and Risk Management" focus group, they were told how accounting know-how served as a solid foundation for a later move into risk management.

"Although it was very hectic as an auditor in an accounting firm, the experience was highly rewarding," said one speaker, Ken Lin, who is senior manager for risk advisory at Baker Tilly Hong Kong Risk Assurance. "I especially enjoyed working as part of a team and made many great friends."

His colleague, Patrick Tong encouraged the students to think carefully about possible career paths and to recognise the breadth of opportunities.

Keith Lee, associate director for forensic accounting at Deloitte China, described some of the specific cases he has handled. He pointed out that his field now encompasses many areas such as business intelligence and forensic work to track evidence in computer files or databases.

At the "Strategic Management" focus group, which was led by Patrick Kwok, general manager of Starbucks Coffee Singapore, many students were curious about possible paths from auditing into business analysis. Kwok said auditors have to pore over company reports and financial statements, which gives them insights into different types of operation. Such experience proved a good grounding in risk assessment and business analysis, Kwok said.

Stephanie Chan, who worked in risk advisory at Deloitte for a while, felt Kwok's talk was inspiring in the way it outlined how an accounting qualification could open up different options and specialist areas.

Marko Yu, a Year 2 accounting student at the Hong Kong Polytechnic University, had attended a previous career forum and felt the new focus group format was effective in bringing participants closer together. "It lets students feel at ease and encourages them to interact more with the speakers more," Yu said. "I especially enjoyed the forensic accounting focus group because the

case study featured a storyline, and it was interesting to hear how the speakers approach an investigation."

At the "Accounting with New Technologies" workshop, Stanley Yung, partner of advisory services and Hilbert Tsang, senior manager of advisory services at EY, took the audience through some of the latest advances in digital technology and explained the possible implications for businesses.
